No. Br-IV/XXVIII-55/70/564—21st June 1972—In exercise of the powers conferred upon me under provisions of section 124 of Municipal Administration Ordinance, 1960, I, A. N. M. Shamsul Alam, Commissioner, Khulna Division, do hereby accord sanction to the following bye-laws framed by Khulna Pourashava under provision of sub-sections (2) and (3) of section 52, read with section 122 of the same Ordinance for ensuring supply of drinking water to private and public premises from the Pourashava water supply distribution pipes. These bye-laws will have immediate effect throughout the Khulna Poura area from the date of publication in Bangladesh Gazette:

Bye-Laws

So long as the Pourashava deems it practicable and consistent with the maintenance of an efficient water supply, any owner or occupier of a holding paying water rate may be allowed to lay down water connection pipe from the water supply distribution pipes of the Pourashava for the purpose of leading water to such holding for domestic and other purposes subject to the following Bye-Laws:

- 1. The owner or occupier of any holding requiring water connection pipe to be laid on to such holding for domestic purposes or requiring any addition or alteration to any existing water supply must apply for the same to the Water Works on the printed form to be supplied free of cost at the Water Works Office.
- 2. (a) A fee for the water connection at the following scale depending on the size of the ferrule, must be paid by such owner or occupier for each connection before any work is commenced:

		Taka.
(i) For 4" dia. water connection		300.00
(ii) For 3" dia. water connection		500.00
(iii) For 1" dia. water connection		1,000.00
(iv) For 12" dia, water connection		2,700.00
(v) For 2" dia. water connection	***	4,800.00

1½" dia. and 2" dia. water connection will be allowed for exceptional cases only, i. e., for Industrial and Commercial purposes only.

On receipt of the above requisite fee, the Pourashava shall undertake the responsibility of extending the water pipe line up to the property line of the applicant including supply of ferrule, pipe, fittings, etc., for connection up to 1" size subject to the condition that such property line will be within 30' fet from the centre of the road.

The extra cost on account of connection of pipes fittings, etc., including labour charges beyond 30' from the centre of the road shall be paid by the applicant at actual cost of labour and materials plus 10% for over-head expense.

- (b) For conversion from small size to large dia, water connection, the owner or occupier shall pay the amount equal to the difference of fees for such connections.
- 3. For temporary water connection for a period not exceeding one month, the connection fees shall remain the same as mentioned in the previous section, except in cases of temporary water connection of public welfare nature such as scouts and other rallies, important religious and political gatherings, sports meets and other important public or State functions in which cases the following concessional rates may be charged as connection fee with maximum of one inch size connection:

Taka.

(i) For ½" dia. size water connection 150.00 (ii) For ¾" dia. size water connection 200.00 (iii) 1" dia. size water connection 250.00

In exceptional cases the Chairman of the Pourashava may at his discretion reduce the rate further.

- 4. The owners or occupiers of holding having water connections shall pay the following water charges in addition to the usual water rate payable alongwith conservancy, lighting rates, etc., levied by this Pourashava:
 - (a) For a water connection to a holding for domestic, commercial or industrial purposes the following monthly water consumtion charges shall be payable:

Taka

(i) For ½" dia .. 4.00 per month or portion or 2.00 per 1000 gallons or fraction thereof if metered.

(ii) For 3" dia	. 8.00	Ditto.
(iii) For 1" dia		Ditto.
(iv) For 11 dia	40.00	Ditto.
(v) For 2" dia		Ditto.

(b) For a connection for constructional or any other special purposes the following water charges shall be payable:

Taka

- (i) For ½" dia. water connection 15 per month or fraction of a month.
- (ii) For ½" dia. water connection 30.00 Ditto. (iii) For 1" dia. water connection 50.00 Ditto. (iv) For 1½" dia. water connection 100.00 Ditto.
- (v) For 2" dia. water connection 200.00 Ditto.

 (c) For water connection for public Gardens/Parks

not exceedingly 3" dia, water consumption charges at the rate of Taka 25:00 per month or part thereof shall be payable.

- (d) For water connection for fire-hydrants the water consumption charges at the rate of Taka 10:00 per month or part thereof for a 3" dia, hydrant shall be payable.
- (e) Bulk water supply to the vessels or at any public functions can be made on a charge at the rate of Taka 2.00 per 1000 gallons or part thereof plus cost of fuel at the rate of Taka 5.00 per trip if Pourashave transport is used for the purpose:
- 5. Except as provided below, each holding must have a separate connection to the Pourashava water supply pipe and extension from the communication pipe of one holding to another holding shall not be permitted:
 - (a) Provided that with the consent of the Pourashava, connections to two or more holdings may be permitted from a comman communication pipe. Any such communications pipe must be laid in a street or common passage and a stop cock as provided for in section 9 must be fixed on the connection to each holding. If available, a meter must also be fixed.
 - (b) Provided also that no holding shall have more than one separate connection, but if in any case the Pourashava are satisfied that an adequate supply to any holding can not be given through a single connection, they may sanction a second connection thereto.
- 6. The owner or occupier of the holding in respect of which the connection is required must pay the entire cost of the connection including the supply and fixing of the fittings referred to in section 2 and must also pay the cost of such alteration in or repair to roads, drains, sewer, gas or water mains or pipes and the cost of such other works as may be necessitated by or resulting from the works of making such connections.
- 7. The owner or occupier of the holding to which a connection has been given must at any time, on receipt of notice to do so from the Pourashava, pay the entire cost of any repair or alterations to the communication or any part thereof that the Pourashava may consider necessary to put into a satisfactory condition, or which may be necessitated by any charge in the Pourashava Water Works or system of distribution or by the defective condition of the connection or any part thereof or any other cases whatsoever.
- 8. (i) The works required under sections 6 & 7 may at the option of the Pourashava either be carried out by the Pourashava at the expense of the owner or occupier of the holding in respect of which the works are required or may be carried out by a person or firm employed by such owner or occupier with the previous sanction of the Pourashava.
- (ii) The works shall be done under supervision of the officer appointed by the Pourashava in this behalf, and no connection must be made with the Pourashava water-main except at such time as may be selected by an authorised Pourashava Officer.
- 9. A holding connection shall comprise the following parts and fittings:
 - (a) A brass or gunmetal ferrule inserted in the water supply pipe.
 - (b) A galvanised iron communication pipe from the ferrule to the meter, if any or a stop-cock.
 - (c) A stop-cock and its surface box.

- (d) Meter.
- (e) Service pipes from the stop-cock to the tap end.
- (f) Taps.
- 10. (i) All the fittings referred to in section 9 shall be the exact duplicates of standard samples kept in the Pourashava office duly approved.
- (ii) All the fittings shall be inspected and tested and stamped by an officer of the Pourashava before being fixed.
- (iii) If any owner or occupier desire to adopt any fittings of a pattern different from the standard pattern, he must present such fittings for the approval of the Pourashava and any fittings so presented may, if considered satisfactory, be stamped and samples thereof may be purchased and placed among the standard fittings.
- 11. Every communication pipe must be capable of withstanding a pressure of a column of water 50 feet in height and must be of a quality approved by the Water Works Superintendent of the Pourashava.
- 12. On every communication pipe a brass or gun-metal stop-cock having the same water way as such pipe be placed as near as practicable to the point where that pipe enters the holding to be supplied. The stop-cock shall be built in a brick chamber provided with a cast iron surface coverbox so designed that it can be locked and the key of the box shall remain under the control of the Water Works Superintendent. The stop-cock shall be capable of adjustment so that the supply to the holding may be regulated thereby.
- 13. The meter, if any shall be placed as near to the stop-cock as possible and in a position where it can be conveniently examined. It must be fixed in a brick chamber covered over with a cast-iron surface-box of approved pattern with locking arrangement and the key of the box shall remain under the control of the Water Works Superintendent.
- 14. Neither the stop-cock nor the meter should ordinarily be placed in any private premises, but if placed in a private premises at the request of the owner, the officers authorised by the Pourashava to inspect or read meters will have free access to that place.
- 15. The Pourashava shall depute an authorised person to read every meter not less than once a quarter and shall give notice to occupier at least 24 hours before the reading is recorded.
- 16. In the case of a meter ceasing to register the quantity of water consumed during the period the meter had cease to register shall be calculated on the basis of average consumption of water of the holding for the last four quarters.
- 17. The Pourashava may cut off the connection between any Water Works of the Pourashava and any holding to which water is supplied from such works or may turn off such supply in any of the following cases, viz.:
 - (a) If the holding is unoccupied.
 - (b) If the occupier refuses to admit any officer duly empowered in that behalf into the holding for the purpose of making any examination or inspection authorised under the Municipal Administration Ordinance, 1960 or under any Bye-Law or rule framed under this Ordinance, or prevent such officer from making such examination or inspection.

- (c) If the owner or occupier of the holding touches or interferes with the meter in any way except with the permission of the Chairman of the Pourashava, or wilfully or negligently injures or damages it.
- (d) If the owner or occupier of the holding wilfully or negligently permits waste of water in such volume as will, in the opinion of the Chairman, endanger the water supply in the neighbourhood.
- (e) If the owner or occupier of the holding refuses or neglects to pay any of the fees or charges imposd in accordance with these bye-laws for a space of fourteen days after he has been served with a notice of demand for the same.
- (f) If the owner or occupier of the holding constructs or fixed any cistern, tanks, reservoir, taps, pipes or any other works in connection with the water supply not authorised by these bye-laws.
- (g) If the pipes, taps, ball-cock, cistern or any other parts of connetion are in a leaking condition or in a state of disrepair.
- (h) If the owner or occupier fails to observe any of the condition made in these byelaws:

Provided that such disconnection or turning off of a water supyly shall not relieve any person from any liabilities which he may have incurred under these bye-laws.

In circumstances contemplated in clause (b) an officer authorised by the Pourashava in this behalf by a general order shall have the power to turn off the supply for a period not exceeding eight hours on his previously recording his reason in writing.

- 18. Every tap shall have the same size as the pipe to which it is attached and shall be of brass and of the pattern known as "Screw down". Every tap shall be at least three feet above the surface of the ground beneath.
- 19. No cistern, tank or reservoir of any description which is intended to be supplied with water from Pourashava Water Works shall be permitted to any holding except with the sanction of the Pourashava and such sanction shall distinctly specify the dimensions and capacity of the cistern, tank or reservoir allowed. The inlet to every such cistern, tank or reservoir must be controlled by any efficient ball-cock so that the discharge thereinto is completely stopped when the cistern, tank or reservoir is full.
- 20. No connection shall be permitted to any holding unless and until the owner or occupier makes effective provision to the satisfaction of the Pourashava for draining all waste water away.
- 21. Whenever any communication pipe has to be laid accross a sewer or open drain or in any place where, in the opinion of the Pourashava, it is liable to injury or contamination such pipe shall be laid through a cast iron pipe of sufficient length to afford due protection to the communication pipe.
- 22. All water rates and dues connected with water connection and consumption shall be recovereble as public demand under the Public Demands Recovery Act, 1913.
