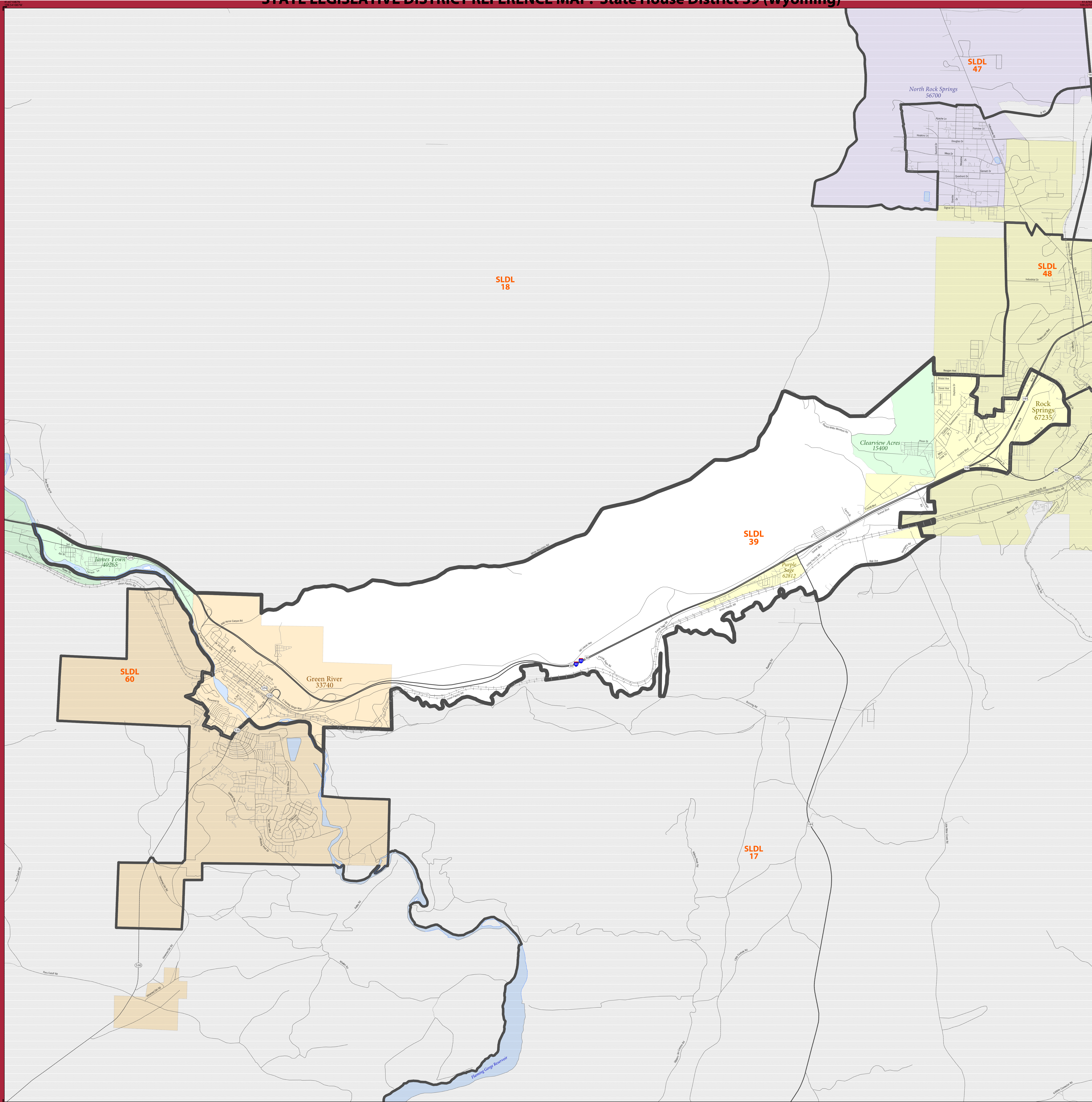


STATE LEGISLATIVE DISTRICT REFERENCE MAP: State House District 39 (Wyoming)

(Note that Illinois and Nebraska have some counties covered by nongovernmental precincts and Missouri has most counties covered by nongovernmental townships.)
